## BEAUVAIS LAKE PROVINCIAL PARK

### FIRSTLY:

All those parcels or tracts of land, situate, lying and being in the fifth (5) township, in the first (1) range, west of the fifth (5) meridian, in the Province of Alberta, Canada, and being composed of:

Sections twenty-nine (29) and thirty (30), the north half and south east quarter of section nineteen (19), the north half and south west quarter of section twenty (20) and the north west quarter of section twenty-one (21) of the said township, containing nine hundred eighty-eight and eighty thousandths (988.080) hectares (2,441.51 acres), more or less.

### SAVING AND EXCEPTING:

- (1) Two and six hundred seventy-nine thousandths (2.679) hectares (6.62 acres), more or less, required for a surveyed roadway, as shown upon a plan of survey of record in the Land Titles Office at Calgary for the South Alberta Land Registration District as No. 751 0054.
- (2) Five hundred ninety-nine thousandths (0.599) of a hectare (1.48 acres), more or less, required for a surveyed roadway, as shown upon a plan of survey of record in the said Land Titles Office as No. 2307 B.M.

### SECONDLY:

All those parcels or tracts of land, situate, lying and being in the fifth (5) township, in the second (2) range, west of the fifth (5) meridian, in the Province of Alberta, Canada, and being composed of:

- (A) The south east quarter and legal subdivisions three (3), five (5) and six (6) of section twenty-five (25) of the said township, containing one hundred thirteen and three hundred sixteen thousandths (113.316) hectares (280.00 acres), more or less.
- (B) All those portions of the north east quarter of the said section twenty-five (25) and the south east quarter of section thirty-six (36) of the said township required for Block one (1), as shown upon a descriptive plan of record in the said Land Titles Office as No. 921 2242, containing sixty-two and four hundred thirty-three thousandths (62.433) hectares (154.27 acres), more or less.

The lands herein described contain one thousand one hundred sixty and five hundred fifty thousandths (1160.550) hectares (2867.68 acres), more or less.
